These Terms and Conditions shall apply to the provision of before and after school childcare at Guildhall Feoffment School. The facility is known as "The Mix". Any variation to these Terms and Conditions will be notified in writing by the school.

Opening Times and Fees

The Mix offers the following sessions, Mon – Fri weekly, term time only at present:

| Morning session | 7.45am – 8.45am | £5.50 |

| Afternoon session 1 | 3.15pm – 4.45pm | £6.60 |
| Afternoon session 2 | 3.15pm – 5.30pm | £9.20 |
| Afternoon session 3 | 3.15pm – 6.15pm | £11.00 |

The school may vary these opening times and shall give written notice to parents of any such changes with as much notice as possible. In extreme circumstance such as staff shortages, emergency precautions, it may be necessary to cancel sessions at short notice.

The Mix will be closed on all public and bank holidays.

Bookings

All booking must be made and paid for in advance via Schoolmoney (Eduspot). https://login.eduspot.co.uk/public/portal/parent/

Parents will automatically be given a user name and password at the time their child enrols at Guildhall Feoffment School. The Mix is not available to children not on roll at Guildhall Feoffment School.

Bookings are available for a term at a time.

In order to plan the staffing rotas, registers will close at 3.30pm each Wednesday for the following week. A "final reminder" will be sent via text message each Tuesday.

Once a booking period has closed, no cancellations will be possible and fees will remain payable for any booked sessions. Cancellations made for periods that are still open will result in a credit being available to pay for future sessions.

Refunds will not be made for a child who is absent due to sickness, including COVID related absence.

Late booking in case of extreme emergency will be considered on an individual basis and will incur an administration fee of £2.50.

If children arrive at the after school club who are not booked in, they will be taken to the school office and parents will be asked to make arrangements for them to be collected.

Places are limited to a maximum of 55.

If you will be late collecting your child for any reason, please contact the emergency mobile number: 075149 874420. This is not to be used for any other queries or to make bookings as it will not be manned during office hours.

Late collection fees will apply. Where a period in excess of 5 minutes has elapsed from the end of the session booked, an additional charge will be made at the rate for the subsequent session(s).

Late collection beyond 6.15pm will not be tolerated. The club closes at 6.15. Where collection goes beyond 6.15pm, additional charges will be assessed on an individual basis and will take into account relevant staffing and any other costs. The school reserves the right to contact emergency contacts to collect your child if you have not arrived for 6.15pm in order to ensure the safeguarding of the child.

If a child remains uncollected at 6.20pm, and no satisfactory explanation has been received, the schools' Child Protection and Safeguarding Procedures will be implemented. This may ultimately involve contact with Children and Young Peoples Services (CYP).

Children arriving at the before school club must be accompanied by a parent/carer in order for them to be signed in and checked against the register. Please do not permit your child to arrive unaccompanied. In instances where children arrive at the club who are not booked in, we reserve the right to charge an administration fee of £20.

All Fees are to be paid via Schoolmoney (Eduspot) at the time of booking. Cash and cheque payments will not be accepted. See below if you wish to pay with Childcare Vouchers.

If sufficient places have not been booked to maintain the financial viability of The Mix, Guildhall Feoffment School reserves the right to postpone or cancel sessions.
